In consideration of being permitted to participate in any past, present or future event organized by or for Morgan Sports Car Club of Canada, I do hereby release and forever discharge the Morgan Sports Car Club of Canada together with its current and former directors, officers, members, spouses of members, guests of members, volunteers, agents and suppliers (individually and collectively "MSCCC"), and do hereby waive any and all claims that I have or may have in the future against MSCCC, from any and all claims, demands, actions, causes of action, costs, losses and liabilities of whatever kind and nature, arising from, or in any way connected with my participation in any such event, including my use, operation, inspection, repair, modification or testing of any automobile or automobiles at or during any such event. This Waiver and Release shall apply to and include all damages, injuries, costs, losses or expenses including property damage, bodily injury or death arising from, or by reason of, directly or indirectly, any accident, incident or occurrence during, or in connection with, any such event, whether such accident, incident or occurrence is as a result of negligence on the part of MSCCC or otherwise.

I acknowledge that I have read and fully understand the foregoing, and that no one is authorized to vary the terms or provisions of this instrument, or to make any binding representation contrary to the provisions hereof. In entering into this Waiver and Release, I am not relying on any oral or written representation or statements made by MSCCC with respect to the safety of participating in any such event.

As a driver, I certify that I have a valid driver's license, that I am authorized to drive in the Province in which the event is being conducted, and that I have valid automobile insurance throughout the period of the event with a minimum of \$1,000,000 third party liability coverage in relation to any vehicle I may drive to or in any such event. As a driver or passenger, I certify that I am fit to participate in this event, and that I will comply with all applicable government laws and regulations.

The terms and provisions of this waiver shall be binding upon me together with my heirs, executors or administrators. I certify that I have read the foregoing, understand that I have given up substantial rights, that I have signed it freely and without any inducement, assurance or guarantee being made to me and that I am fully responsible for my actions.
